Guidelines and Eligibility Criteria

SCHOLARSHIP TYPE & ELIGIBILITY

The American Society of Military Comptrollers (ASMC) and Kearney & Company are pleased to offer **ONE** \$1,000 scholarship and **ONE** \$500 scholarship to two Cleveland Chapter ASMC Members currently pursuing college degrees. Scholarships must be applied towards college tuition and/or books.

QUALIFICATIONS

Scholarships will be awarded based on a candidate's potential for making a meaningful contribution to government service through ASMC and through the established scholarship criteria. Academic achievement prior to application is an indication of potential for successful study, but is not the only criteria that will be considered. To qualify, the applicant:

- Must possess a minimum grade point average of 2.5 on a 4.0 scale
- Must be an active member of the ASMC Cleveland Chapter

THE ESSAY

Applicants must submit a minimum 500-word, double-spaced essay on the topic below. Please include your full name and contact information on the cover page of your document.

A mission statement is a formal summary of the aims and values of a company, organization, or individual. Create a mission statement for yourself. Explain your personal mission statement, and expand on how it compares to that of your agency/employer and that of ASMC. Does your personal mission statement align to one mission statement over the other?

DEADLINE

Scholarship applications and required documentation must be received by the close of business on **Friday, February 21, 2020**. No incomplete or late applications will be considered.
