## ASMC Cleveland Chapter Fights Hunger with the Greater Cleveland Food Bank (GCFB)

# **84,700** new people served in FY2022, meaning they have visited an emergency

## feeding program for the first time.

The ASMC Cleveland Chapter always steps up to volunteer and serve the communities and families in NE Ohio. ASMC members volunteer monthly to help fight hunger with the Greater Cleveland Food Bank (GCFB). Community service is way to give back and help make communities stronger and more resilient than before. When we volunteer at the GCFB, we know that our efforts have a tremendous impact for NE Ohio children, families, adults, and seniors.

Food insecurity is a reality for many families across America, and the number is steadily growing in many U.S. cites. Right here in the Cleveland and other NE OH communities, people are experiencing difficulties with having enough food. The first-time families that visited the GCFB doubled during the pandemic to an average of 6,000 each month (clevelandfed.org). The GCFB feeds six Ohio counties, which include Cuyahoga, Ashland, Ashtabula, Geauga, Lake, and Richland.

# **349,000** people served by the Food Bank and its over 1,000 partnering agencies over six counties.

Statistics show the number of families visiting food banks and pantries increased by "6.7% nationwide in 2020 during the pandemic, up by 4.4% from 2019 (clevelandfed.org)."

According to the USDA, "more than 34 million people, including 9 children, in the United States are food insecure

(ww.feedingamerica.org)." The numbers keep climbing, in such that million people, nationwide, are turning to food banks/community pantries for food assistance in 2022 (feedingamerica.org).

In relation to Cuyahoga County, "food insecurity reached more than 2020; then a slight declined was recorded to 16 percent in 2021

(clevelandfed.org)." Although there was a decline NE Ohio, reports showed that "200,000 county residents still experience food insecurity in 2021 (cleveandfed.org)."

Over several months, ASMC members volunteered at GCFB to help repack 3,200+ pounds of food. Also, in the month of October, we created children bookbag snack bags that children receive on Friday afternoons so they will have food over the weekend.

There is still a strong need to ensure all families can put food on their tables daily. It takes all of us to help fight hunger across the United States and right here in Ohio. If you are interested in volunteering, please reply to the community service announcements. In the future, there will be opportunities to volunteer at both the GCFB current location and/or the new food pantry located at the former GCFB location on Waterloo Road. We welcome all to join us to volunteer for a good cause!

## ASMC Professional Development Institute 2024 (Phoenix, AZ)

Save the date for Professional Development Institute (PDI) 2024!

The PDI is ASMC's premier training event and will take place on May 29 – 31 in Phoenix, Arizona at the Phoenix Convention Center. Registration will open on March 1, 2024.

Join ASMC for this fantastic opportunity to learn and interact with participants from Service HQs and major commands, and to collaborate with leadership and peers. This event also showcases individuals and teams recognized by ASMC for their excellent contributions to the field of defense financial management in 2024. The PDI 2024 program will include general and Community Day sessions, mini-courses, and sessions focused on multiple defense financial management competency areas.

## CDFM Pilot Testing – Open to Active CDFMs and CDFM-As

Active CDFMs are eligible to pilot test newly developed Certified Defense Financial Manager (CDFM) exam questions!

ASMC is collaborating with the Human Resources Research Organization (HumRRO) to update the CDFM certification exams. As part of this initiative, newly developed exam questions (items) need to be pilot tested by current CDFM and CDFM-A certificants. The data obtained is analyzed to assess item quality and determine which new items are ready to be added to the live exams.

#### What are the benefits of volunteering to pilot test?

Your input is vital for creating representative and valid CDFM certification exams. By volunteering, you contribute meaningfully to the Defense Financial Management field. Additionally, you will earn 2 CPE credits and an entry to win an Amazon gift card for each pilot test you complete.

#### What does pilot testing entail?

This opportunity involves spending approximately 60-120 minutes taking an online test. Each pilot test has 90-110 multiple-choice questions in the same format as the questions on the CDFM exams you took to earn your credential. We ask that you please DO NOT PREPARE for the CDFM pilot tests. These tests are NOT SCORED. Taking these tests has NO IMPACT AT ALL ON YOUR CERTIFICATION. We understand that you may not have current knowledge in all content areas.

#### How do CDFMs access pilot tests?

The ASMC certification team sent an email to active CDFMs and CDFM-As on December 18, 2023. This email contains links to the three pilot tests. You can take one, two, or all three pilot tests.
